BSCM Family,

As a family of Christians, over the centuries, we Baptists have developed some standards that we deem appropriate by which we should conduct ourselves. Some of them are etched in stone and have been canonized almost to the level of Scripture. In fact, if you were to do a brief survey in our local churches you might



discover that some of our standards, rules, and regulations are easily confused for directives from God Himself.

Since my early days as a Believer, I have been fully convicted or I should say, convinced that certain words should not be ushered forth from the tongue of the redeemed. Obviously, I will not list any of those "foul phrases" here but there is one word in the realm of our Baptist Zion that could be very well listed among these unutterables and considered the king of cuss words. It is a word that brings fear, trembling, and gasps of appalling disbelief and shock. A word so despised by many in our Christian family that when heard, fainting and sheer panic have been known to set in among the masses. At times, anger has been known to take control of the most timid of souls and fist fights have broken out in the church foyer.

What is this vile and despised word? CHANGE!

The most dreaded word among Southern Baptists ever known.

We are so averse to the word change and all its implications that we in many instances will substitute alternate phrases and vernacular to soften the stench and sting of the word. A few of those substitute words or phrases are: transition, paradigm shift, new direction, restructure, cultural move, revamping, conversion, metamorphosis, and so on. But the truth is that they all mean or relate to change.

The old adage is that "the only person in a Baptist church that wants to be changed is a baby in the nursery and they fuss and cry about it the whole time!"

Some things should never change. They are the bedrock truths of our Faith and Belief. The Gospel has always been, is, and will forever be the Gospel. Steadfast, immoveable, and eternal!

Yet certain changes are needed and an inevitable part of a Believer's life and the life of the Church.

I don't particularly like change and that is especially true the longer I live on this terrestrial ball. I like my stuff and I don't want you messin' with it. I can get very grumpy when my "normal" gets replaced with someone else's normal. It is during those times I have to step

back and try to view things from God's perspective and not my own. That is when I have to relinquish my rights and wishes to His will and His sovereign wisdom, knowing that He sees what I do not, and that He is fully in control.

There is nothing more precious than a newborn baby and the pride and joy they bring. The anticipation of growth and development and what the future holds, brings great excitement and wonder to the parents and family of these gracious gifts from God. The most natural and wonderful expectation is that this little creation of God will grow and change over the months and years to come. Yet few things bring more sadness and heartbreak than when a physician informs the parents that their little one will never fully develop past a certain stage, whether that be mentally or physically. It is devastating. It is not normal.

Change is the normal and natural process that God has built into the DNA of our bodies and minds. When that does not occur, the results are beyond sad.

In the next months and years there will be many changes among our BSCM family. Some of us will embrace the change and rejoice while others may become grumpy and angry because someone is "messin' with your stuff" or 'things don't seem normal."

Change is not easy for any of us, but the absence of change is not normal. To remain the same is to cease to grow.

It is my prayer that this will be the best year in the history of our Convention Family as we grow and change together so that the *unchanging Gospel* may be proclaimed among the people of Michigan and that "holes may be punched in the darkness that surrounds them."

Wayne Parker, SEND City Missionary SEND Detroit Report

Because we are a Kingdom-minded people, our hearts must be drawn to places where people live, and the Gospel must be proclaimed. With a population of 4.7 million people, Send Detroit holds nearly one half of the total state population. There are many communities that need a gospel-centered church. For example, in Oakland County, Transformation Church is the first SBC church to have been planted in over



20 years. We are thankful for this new church, but we need to continue to pray for many others like her.



Our Send Detroit City Team works to help coordinate support for our planters and potential planters. We host "Catch the Vision Tours" to invite pastors and church leaders from around the country to come and see our city, meet with planters, and pray about how they can partner. We are thankful for

churches from Arkansas, Texas, North Carolina, Illinois, and Georgia who are partnering with our planters. Our team also manages the assessment process for planters in Michigan. This past year, we had 16 couples go through the 2-day retreat. We also provide peer-coaching relationships for all our planters, training cohorts, and coordinated care events to give planters and their families time together in fellowship.

Following the pandemic years, many of our church plants have had great difficulty finding places to meet. Historically, many of our churches launched in local schools. In many communities, policy changes have made it either too expensive or impossible to rent school space for worship. I am pleased to report that 6 of our new churches have been able to enter a long-term lease, purchase, or receive the gift of a building for worship and ministry. Each is an answer to prayer.



One of our most recent launches to celebrate is Aramaic Baptist Church in Troy. Pastor David Selou launched public worship services in July. The Northfield Hills Baptist Church has graciously opened their doors to host this new congregation. We are excited about this new Gospel witness to our Arabic community on the north side of Metro Detroit. Pictured are David, his wife, Rawa, and their two daughters.



We want to thank you for making these efforts possible. Your church's gifts to the Cooperative Program provide support and encouragement to these kingdom efforts. Please continue to pray that God raises up labors for the harvest. I would love the opportunity to help your church explore a partnership with a new church plant in Detroit. Mike Durbin, State Director of Evangelism Church Strengthening Report

Thank you for the privilege of serving the churches of the Baptist State Convention of Michigan! One of the greatest joys of my life has been to work alongside our wonderful state staff. The men and women who serve our Convention of churches are some of God's choicest.





I've heard Tim, Tony and I called everything from "The Three Musketeers to The Three Stooges." I'm partial to "Los Tres Amigos." God has blessed me more through these men than I could ever express. That being said, I will be retiring from the BCSM at the end of this year. I do so with many wonderful memories and great hope for the future of Michigan Baptists. The best is yet to come!

Strategic alignment is taking place that reflects our BSCM mission to help churches take their next step to accelerate

Gospel movement. In Strengthening Churches that means focusing on several key areas that help churches generally, even as we engage in discussions unique to each church: leadership development, church revitalization, pastoral care, and evangelism are key areas to strengthen churches.

Be The Church (BTC) impacts churches in the area of spiritual leadership development. Monthly pastor cohorts and BTC Summits drive leadership development in churches. Two BTC Summits were held: one in December at Calvary Church Southfield, and one at Westside Church in Flushing. Pastors gathered with leaders from their churches around tables to discuss next steps for each church based on the leadership truths taught by Pastor Joel and Pastor Luke. The lessons led to excellent discussions by the church teams as they considered next steps. New curriculum has been developed and released that will assist churches as they take next steps.



Stand out statements from the Summits:

"The greatest division in churches today is not theology - it is church size. If you don't change the way you operate, you will never grow."

"Christ is the head of the church, I am not. Do my actions support that Christ is head of the church?"

"You cannot control a movement of God."

Church Revitalization is a need in churches across the state. It is estimated that 90% of

churches in North America need some level of revitalization. Many have seen the life cycle of churches pictured as a Bell Curve. The top most point of the curve is when a church is thriving and healthy. People are coming to faith in Christ and growing as disciples. It is a time of growth - spiritually and numerically. Vision drives everything as more and more disciples are made. Organizational structure is developing in such a way that it maximizes evangelism and discipleship. The focus is on reaching people with the Gospel and making disciples, not maintaining the organization.



The top of the curve is the proverbial "Mountain Top" new churches long to reach and declining churches look backward to on the downward slope. Many churches are looking backward toward the mountaintop and need help turning things around. That's why we have partnered with Corpus Vitae to help churches seeking revitalization through their six step refocus process. Dr. Rob Peters, founder of Corpus, has been with us in Michigan to introduce the Refocus process to more than 60 leaders from around 20 churches. "Corpus envisions a world where vibrant churches and effective pastors impact their communities with the gospel. Our customized church revitalization approach will fit your church revitalization needs with accurate assessments, a biblically-based process, and continued support."



Pastor Care took a momentous step forward with the coming of Garth (and Patty) Leno. His experience as a Pastor/Church Planter uniquely equips him to connect with pastors and their families. Garth's impact was keenly felt by those who attended the Pastor/Wife Refresh Retreat at The Shack in August. He spoke wisdom from the life of a pastor into the lives of pastors during the encounter.

Pastor Tim Patterson and I had the opportunity to attend The Pastor Wellness Summit at Guidestone. We are grateful for Hance Dilbeck (President of Guidestone) and the entire Guidestone team. Their love and commitment to serve pastors is palpable with everyone you meet at Guidestone. One exciting outcome is that Michigan partnered with Mission Dignity to provide a thirteenth check for retired Michigan pastors and their wives (currently 7). Mission Dignity gives us the opportunity to express our appreciation once again for these faithful servants of the Lord and their ministry in Michigan.

A group of 17 gathered in May at Bambi Retreat and Conference Center to start the Pastor Re:Focus Journey. Over two years, they will build deep relationships with each other as they experience four retreats and monthly zoom cohort meetings. Michigan Pastors from the first two year Journey are co-leading the new group with the Re:Focus team from Texas.

One of our cohort facilitators from Refocus shared, "Pastor Tod is a totally different man. He has joy on his face and in his heart. He is allowing the Lord to change him (his transformational goal) and he is experiencing the joy of the Lord as he allows himself to be the man God has created him to be. He is allowing God to use his brokenness instead of hiding it! People are responding and his church is growing."

Evangelism resources for churches continues to be a priority for the BSCM, including the recently released NAMB Evangelism Kit that you can pick up today.

Our annual Youth Evangelism Conference was held at Westside Church, March 17th - 18th. One mother posted, "Our son is one of the kids that accepted Jesus Friday night. Thank you... for the Conference and the impact you are having on kids." Her son was one of 35 students that personally confessed, "Jesus is my Lord and Savior" over the weekend. More than 150 students were trained to share the Gospel and engaged in a mission project Saturday. We are grateful for all who worked so hard to make this event an eternity changing time for students!

I am thrilled to share that through our partnership with the North American Mission Board, the BSCM has invested \$82,447.58 in Evangelism Grants to Michigan Baptist Churches during this fiscal year. The impact will be reported in the weeks to come as churches share their stories with us. Our strategy is to help churches take evangelism to the next level through these grants. Churches are using these resources for block parties, gospel concerts in community parks, outdoor movie nights, back to school events, and many other ways.



A team from the State Convention of Baptists in Ohio led an animated group of Michigan Baptist leaders in a state-wide VBS Clinic at Lakeside Community Church in St. Clair. The Ohio team showed us how to engage students through LifeWay's "Twists & Turns."

Lakeside Church in St. Clair hosted the equipping event. As a result, Lakesides'

VBS attendance grew to 113 children this year, up from 53 last year! The clinic helped multiple churches jumpstart their preparation by sharing how to use the materials and creative ideas to engage the children. The BSCM made \$250 grants available this year to help churches conduct VBS.

Planning started in January to bring the **Send Relief Serve Tour** to the greater Flint area, August 9-10, 2024. The Serve Tour is a national mission trip that partners with state conventions, associations, and local churches to inspire engagement in compassion ministry. Ed Emmerling and Jerome Taylor are serving as the Project Managers and will lead the compassion ministry efforts in the greater Flint area. The **Serve Tour** mobilizes churches to bless the target area through meeting needs and sharing Christ. It provides an opportunity for volunteers from churches in Genesee Association, across Michigan, and the broader SBC to serve schools, churches, bi-vocational pastors, and people in need. It is an excellent mission opportunity for Michigan Baptist Churches to get involved. Prayerfully consider adding the **Serve Tour** to your mission calendar for 2024. This year included the following:

- Over 50 women enrolled in group Bible Studies held at the Ministry Center.
- 60 girls attended Girls Camp at Bambi Lake in July. The theme was "All Day Every Day" Psalm 23:6. Our missionaries Jeff and Melva Clark, sincerely blessed the hearts of the girls and the staff sharing their experiences on the mission field.
- Eighty ministry leaders were trained in mental Health first aid. Mental Health is one of National WMU's focus for 2023/2024 year.
- Christian Women's Job Corps is off to a great start as it prepares for its launch in January 2024 at Temple of Faith Baptist Church. We also have a strong interest for Christian Men's Job Corps and plan to bring that training to Michigan in the very near future.

Going forward, the desire of the Michigan WMU Leadership team is to increase active WMU ministries and activities in the local churches in Michigan. It will be our focus to target new church plants to educate the pastors and women's leadership teams as to the value of WMU in assisting churches to be and/or become a church on mission with Jesus.

Michigan Disaster Relief Report

This year has been extremely busy for Michigan Disaster Relief. In March, we delivered Basic Training and Mass Feeding Training in Redford to over twenty participants including several pastors from the Greater Detroit Baptist Association. We then followed up with Chaplain Training for this group in April. Dr. Mark Wakefield from



Alabama came to Michigan and delivered the training. In May, 40 participants from Cornerstone Church attended Basic Training and Mass Feeding Training.

We also had two important events in May. Our chainsaw volunteers spent a week at Bambi preparing the grounds for the summer visitors. We had a great week of cutting and fellowship. We also conducted ServSafe training on May 16th and 17th for some of our feeding volunteers whose national certification was about to expire. Several new volunteers also attended the training. Two trainers from Kentucky DR came and led the training.

At the Campers on Mission national rally in Michigan in June, Michigan Disaster Relief delivered a program each day explaining what we do and how people can get involved.

In August, Michigan sent a flood recovery team to New Windsor, New York to help homeowners recover from the devastating floods that affected most of the northeast. Not long after the team returned home, Michigan was hit with a serious weather event that included several inches of rain and tornadoes along with straight line winds. Over twenty volunteers spent several days clearing trees from homes in Romulus and Comstock Park in Kent County.

We continue to conduct training for churches and associations as the need arises.

The Executive Committee & Board of Trustees Report to the Baptist State Convention of Michigan

November 3, 2023

Recommendation #1:

 The Executive Committee & the Board of Trustees moves that the 2023—2024 BSCM Proposed Budget be presented to the messengers of the 2023 Annual Meeting for adoption.

Recommendation #2:

- Based upon the 2023 Bylaws Revision provided by the Constitution & Bylaws Revision Team appointed by the BSCM President at the 2022 Annual Meeting, the Executive Committee & the Board of Trustees moves for the adoption of the 2023 Bylaws Revision. The Proposed Bylaws revision was approved by the Executive Committee in the July 18, 2023.
- The Bylaws have been sent to the churches via mail and email per the protocol directed by the current Bylaws of the BSCM.

Recommendation #3:

- The BSCM Executive Committee & the Board of Trustees move that the BSCM sell Bambi Lake Retreat Center to Hiawatha Youth Camp according to the agreed upon terms and conditions for acquisition and ownership of the properties.
 - This sale has been approved by BSCM Board of Trustees and is pending the messengers' approval at the 2023 BSCM Annual Meeting.
 - If the agreed upon terms and conditions are not executed, the BSCM Executive Committee will pursue the selling of properties to other parties.
 - o The terms and conditions are as follows:
 - Sell to Hiawatha Youth Camp Sales Price \$1,450,000.00
 - Initial Payment of \$750,000.00
 - Equity Reserve of \$700,000.00 for the BSCM if sold by Hiawatha Youth Camp
 - If ever sold BSCM would get \$700,000.00 back or half of the sale price whichever is less
 - BSCM would get minimum 6 retreats a year at camp at the customary rate at that time. 4 of these to be weekend only.
 - Hiawatha would immediately begin managing camp after BSCM Annual meeting in 2023 and sale closing would take place by May 31, 2024.

Report #1:

 Based upon the parameters that define the distinctive missions of the BSCM and the Michigan WMU, the Executive Committee approved the transferring of designated funds left under the care of the BSCM's accounting yet under the Michigan WMU purview to the complete oversight of the Michigan WMU's authority and leadership. Much appreciation is extended for the work of the Michigan WMU and the BSCM wants to remove any impediment to the advancement of this vital ministry within our state.

After consultation with the officers of the WMU and the officers of the BSCM, it has been determined to maintain financial accounting of the present and future funds of the WMU but transfer responsibilities of spending and usage, completely to the officers of the WMU.

Report #2:

 The Executive Committee & the Board of Trustees approved the recommendation from the Credentialing Committee (Art Werry, Benjamin Bauer, Jerome Taylor) that First Latin-American Baptist Church, Detroit be received as a church at-large in friendly cooperation with the BSCM and have its messengers seated. The church has doctrine in line with the Baptist Faith & Message (2000) and has a practice of cooperative giving to the CP.

Report #3:

• The Executive Committee received and approved the application of Stan Turner (New City Church, Lincoln Park) and Benjamin Bauer (FBC, Brighton) to the Board of Trustees. The Executive Committee received the resignation of Seth Springs (Transformation Church, Waterford) from the Board of Trustees due to other ministry responsibilities and the resignation of Jon Locke (formerly North End Baptist, Mt Morris) from the Board of Trustees due to relocation in another state.

ADDENDUM to the 2023 Book of Reports

Bylaws of the Baptist State Convention of Michigan

ARTICLE I – LEADERSHIP STRUCTURE

Section 1. Officers of the Convention

1. Election of Officers

- a. The officers of the Convention shall be include President, First Vice-President, Second Vice-President, Recording Secretary, and Assistant Recording Secretary.
- b. The officers shall be elected and installed annually at the annual session by the Convention with their term beginning at the end of the annual session.
- c. The officers shall be elected in the order of their rank, beginning with the President. Nominations shall be made from the floor, with the prior consent of the nominee.
- d. To be eligible for nomination as an officer of the Convention, a person must have been a member of the same cooperating church for at least the preceding one (1) year.
- e. To be eligible for nomination as an officer of the Convention, a person's church must be giving at least five percent (5%) of undesignated receipts to the Convention through the Cooperative Program as reported in the current Annual Church Profile of the church.
- f. In the case of a vacancy, the officers shall succeed in order. In the case of a vacancy in the offices of the Second Vice-President or Assistant Recording Secretary, the Convention officers Executive Committee shall elect someone who meets the eligibility requirements to complete the term until the next annual session.
- g. No person employed by the Convention or any other Southern Baptist Convention (SBC) entity, or his/her spouse, shall serve as an officer of the Convention
 - i. An employee is defined as any person who receives a W-2 from the Convention or any SBC entity.
 - ii. Family members of existing Executive Committee members are ineligible to serve during the tenure of the existing member. Family members include spouses; parents and children (including step- parents and step-children), siblings (including step-siblings); and "in-law" relationships.

2. Duties of Officers

- a. President The President shall preside over meetings of the Convention and the Executive Board of Trustees.
 - i. The President, in cooperation with the Convention's Executive Director-Treasurer, will regularly highlight the Convention's mission, vision, values, and strategy among the cooperating churches.
 - ii. The President shall have authority to appoint ad hoc or special committees as necessary for the work of the Convention and/or in fulfilling the will of Convention messengers at the annual meeting.
 - iii. The President, in partnership with the Convention's Executive Director-Treasurer & the First Vice-President, will complete a quarterly review of the accounting ledger to be followed by a summary report to the Board of Trustees by the First Vice-President. The President shall be a member of the Executive Committee and the Board of Trustees.
 - iv. The President will represent the Convention at appropriate gatherings on the local, state, and national levels when possible.
- b. First Vice-President The First Vice-President shall preside at all meetings in the absence of the President, or at the President's request.
 - i. The First Vice-President shall serve as the Assistant Registration Officer of the Convention. In cooperation with the Second Vice-President, the First Vice-President shall receive, review, and make recommendations, to the Board of Trustees, for churches seeking affiliation with the Convention, and perform an annual review of churches who have ceased cooperating with the Convention followed by a recommended action.
 - ii. The First Vice-President shall automatically accede to the office of the President in the event the office becomes vacant. and shall be a member of the Executive Committee and the Board of Trustees.
 - iii. The First Vice-President shall serve the Convention by working in partnership with the Convention's Executive Director-Treasurer to evaluate, prepare, and present the annual budget for approval by the Board of Trustees and adoption at the annual meeting.
 - iv. The First Vice-President, in partnership with the Convention's Executive Director-Treasurer & the President, will complete a quarterly review of the accounting ledger to be followed by a summary report to the Board of Trustees.

- c. Second Vice-President The Second Vice-President shall preside at the meetings of the Convention in the absence of the President and First Vice- President, or at their request,
 - The Second Vice-President shall automatically accede to the office of the First Vice-President in the event the office becomes vacant. The Second Vice-President shall be a member of the Executive Committee and the Board of Trustees.
 - ii. The Second Vice-President shall serve as the Registration Officer of the Convention and as ex-officio chair of the Credentials Committee. In cooperation with the First Vice-President, the Second Vice-President shall receive, review, and make recommendations, to the Board of Trustees, for churches seeking affiliation with the Convention, and perform an annual review of churches who have ceased cooperating with the Convention followed by a recommended action. In their role as the Registration, they shall aid the BSCM staff in the registration of messengers during the annual or special called meetings.
 - iii. The Second Vice-President shall automatically accede to the office of the First Vice President in the event the office becomes vacant. The Second Vice-President shall be a member of the Executive Committee and the Board of Trustees.
- d. Recording Secretary The Recording Secretary shall keep minutes of the annual session of the Convention and all meetings conducted by the Executive Committee and Board of Trustees.
 - The Recording Secretary shall present any reports requested by the Convention President on behalf of the Convention officers and/or Board of Trustees.
 - ii. The Recording Secretary shall assist the President during the annual and special called meetings with the handling motions and Convention business.
 - iii. The Recording Secretary, working in partnership with the Assistant Recording Secretary shall evaluate, plan, and conduct an annual emphasis encouraging churches to complete and submit their Annual Church Profile.
 - iv. The Recording Secretary shall be a member of the Executive Committee and Board of Trustees.
- e. Assistant Recording Secretary The Assistant Recording Secretary shall keep minutes of all Convention proceedings in partnership with and/or the absence of the

Recording Secretary, and shall automatically accede to the office of the Recording Secretary in the event the office becomes vacant.

- i. The Assistant Recording Secretary shall also perform other duties at the request of the President and Recording Secretary.
- ii. The Assistant Recording Secretary, working in partnership with the Recording Secretary, shall evaluate, plan, and conduct an annual emphasis encouraging churches to complete and submit their Annual Church Profile.
- iii. The Assistant Recording Secretary shall be a member of the Executive Committee and Board of Trustees.

3. Terms of Office

- a. The President, First Vice-President, and Second Vice-President shall be elected annually and can serve no more than two (2) consecutive years in each position.
 - i. If the unfulfilled term is longer than six (6) months, the person is eligible to serve one additional full term.
 - ii. If the unfulfilled term is shorter than six (6) months, the person is eligible to serve two additional full terms.
- b. The Recording Secretary and Assistant Recording Secretary shall be elected annually and can serve no more than five (5) consecutive years in each position.

Section 2. Executive Committee

1. Membership:

- a. The Executive Committee shall be comprised of the elected Convention officers and immediate past president and the chairs of the Church Starting, Church Strengthening, Church Sending, Bambi Lake, and the Michigan Southern Baptist Foundation Mission Committees.
- b. The Executive Director/Treasurer shall serve as a consulting, non-voting member of the Executive Committee.
- c. The immediate past president shall serve as a consulting, voting member of the Executive Committee and Board of Trustees.

2. Eligibility:

a. All candidates for the Executive Committee must have been a member of the same cooperating church for at least one (1) year.

- b. No person or his/her spouse who is an employee of the Convention, or any other Southern Baptist Convention (SBC) entity, of Office shall be eligible to serve on this committee.
 - i. An employee is defined as any person who receives a W 2 from the Convention or any SBC entity.).
 - ii. Family members of existing Executive Committee members are ineligible to serve during the tenure of the existing member.
 - iii. Family members include spouses; parents and children (including step-parents and step-children), siblings (including step-siblings); and "in-law" relationships.

2. Term:

- a. Executive Committee members shall serve no more than two (2) consecutive terms of three (3) years. A person elected to fulfill an unexpired term of less than two (2) years shall be eligible for re-election for two (2).
- b. After the term limit is fulfilled, one (1) full year must elapse before the individual is eligible for re-election.

3. Responsibilities:

- a. The Executive Committee, shall serve in conjunction with the Convention Staff to present the agenda and proposals (including but not limited to the annual budget) to the Board of Trustees for the work of in conjunction with the Board of Trustees, shall have the authority to administer and oversee the work and business of the Convention between annual sessions. This authority includes buying, selling, leasing, and receiving real and personal properties upon the approval of two thirds (2/3) of the Board of Trustees present and voting. shall have the authority to administer and oversee the work and business of the Convention between annual sessions.
- b. shall have the responsibility of recommending to the Board of Trustees, for its approval and submission to the Convention in annual session, an annual budget for the Convention. The Executive Committee shall make a report of all its work to the Convention in annual session.
- c. The Executive Committee shall make a report of all its work to the Convention in annual session.

Section 3. The Board of Trustees

1. Membership:

- a. The Board of Trustees shall be comprised of representatives from the cooperating churches of the Convention, and shall include the Executive Committee elected officers of the Convention.
- b. The Board of Trustees shall be comprised of fifteen (15) members, which shall include the five (5) elected officers, immediate past president, and nine (9) at-large trustees.
- c. The primary responsibility for recruiting Trustees shall be shared by the Executive Committee and the Board of Trustees. The members of the Board of Trustees shall be assigned to specific Mission Committees by the Executive Committee.
 - Trustee candidates shall be approved by the Executive Committee and the Board of Trustees before being recommended to the Convention in session for election.
 - ii. Unfulfilled positions, including partial terms and unfilled positions that would comprise the optimal size of The Board of Trustees may be filled by candidates approved by the Executive Committee the Board of Trustees between annual sessions of the Convention. Such positions shall be presented to the Convention at its next annual session for election to the remainder of that term.
 - iii. Every effort will be made to recruit Trustees who will reflect the diverse make-up of the Convention churches.

2. Eligibility:

- a. All candidates for the Board of Trustees must have been a member of the same cooperating church for at least one (1) year.
 - i. No person or his/her spouse who is an employee of the Convention, or any other Southern Baptist Convention (SBC) entity, shall be eligible to serve on this board (an employee is defined as any person who receives a W-2 from the Convention or any SBC entity.).
 - ii. Family members of existing Board of Trustee members are ineligible to serve during the tenure of the existing member.
 - iii. Family members include spouses; parents and children (including step- parents and step-children), siblings (including step-siblings); and "in-law" relationships.

3. Terms:

a. Trustees shall serve no more than two (2) consecutive terms of three (3) years.

- i. A person elected to complete an unexpired term of less than two (2) years shall be eligible for re-election for two (2) full terms.
- ii. After a Trustee's term limit is fulfilled, one (1) full year must elapse before the individual is eligible for election.
- iii. If the unfulfilled term is longer than six months, the person is eligible to serve one additional full term; if shorter, then two additional full terms.

4. Responsibilities:

- a. The Board of Trustees, in conjunction with the Executive Committee, shall have the authority to administer and oversee the work and business of the Convention between annual sessions.
 - i. This authority includes buying, selling, leasing, and receiving real and personal properties upon the recommendation of the Executive Committee and the approval of two-thirds (2/3) of the Trustees present and voting.
 - ii. This authority includes the arbitration of personnel matters among Convention employees that exceed solutions by the Executive Director-Treasurer.
 - iii. This authority includes oversight of the Michigan Southern Baptist Foundation.
 - 1. In partnership with the Executive Director-Treasurer, the Board of Trustees will give guidance to the fiduciary investments of the Convention.
 - 2. The Board of Trustees will evaluate and implement ways to educate and resource cooperating churches in matters of stewardship, budgeting, and investments.
 - iv. After receiving a budget proposal from the Executive Committee, The Board of Trustees shall recommend an annual budget for the approval of the Convention in annual session.
 - v. The Board of Trustees shall make a report of all its work to the Convention in annual session.

5. Mission Committees:

- a. Committee Leadership:
 - i. The Mission Committee chairs shall be nominated by the President and approved by a majority vote of the Executive Committee.
 - ii. They shall serve on a year to year basis and be part of the Executive Committee.

b. Meetings:

i. Each Mission Committee shall establish its own schedule and protocol for meetings, but shall be required to bring a report at each meeting of the Board of Trustees.

c. Church Starting Committee:

- i. This committee shall work to resource all cooperating churches in developing strategies, aligning partners, recruiting and assessing church starters for new churches.
- ii. This committee shall join the Church Sending Committee in the shared responsibility of mobilizing churches for this Kingdom task.
- iii. The committee shall give assistance to the work of the Convention staff assigned to its tasks.

d. Church Strengthening Committee:

- i. This committee shall work to resource all cooperating churches in developing Kingdom oriented leaders and workers.
- ii. The committee is given the task to be resource brokers for the training and equipping needs of our churches.
- iii. The committee shall give assistance to the work of the Convention staff assigned to its tasks.

e. Church Sending Committee:

- i. This committee shall work to resource churches in evangelism and missions, raising the awareness of our cooperative work through education and involvement.
- ii. The committee shall resource churches to be Acts 1:8 churches to engage their community, state, nation, and world with the Gospel of Jesus Christ.
- iii. The committee shall develop healthy partnerships for advancing God's Kingdom.
- iv. The committee shall give assistance to the work of the Convention staff assigned to its tasks.

f. Bambi Lake Committee:

- i. This committee shall work to oversee the work of the Bambi Lake properties by promoting events and opportunities there, as well as assisting with the planning of a yearly calendar of events.
- ii. The committee shall give assistance to the work of the camp director and Convention staff assigned to its tasks.

g. Michigan Southern Baptist Foundation:

- i. This committee shall work to educate and resource churches in matters of stewardship, investment, and other financial issues.
- ii. The committee shall oversee all fiscal assets of the Foundation and make decisions regarding any allocations from the Foundation.
- iii. The committee shall give assistance to the fiduciary investments of the Convention in cooperation with the Executive Director/Treasurer.

5. Removal of Committee Member:

- a. A Committee member may be removed from serving for ethical or moral failures or any other conduct that would discredit the work of the Convention or the advancement of the Kingdom.
 - i. Addressing failures in biblically appropriate means shall not be viewed as discrediting the Convention.
- b. Committee members Officers and trustees may also be removed for failure to fulfill the responsibilities of a Trustee their role.
 - i. The member's officer's or trustee's removal shall take place with a 2/3 vote of the Executive Committee Board of Trustees.
 - ii. The officer or trustee in question will not be included in the vote.

ARTICLE II – MEMBERSHIP

Section 1. Messengers

The Convention in session shall be composed of messengers who are members in good standing of cooperating Southern Baptist churches, as defined in these Bylaws, and selected by those individual churches.

Section 2. Cooperating Churches

- 1. A church shall be considered a cooperating church when it:
 - a. Supports the vision, mission, and doctrinal statement of the Convention,
 - b. has a faith or practice that is consistent with & not contrary to the current adopted doctrinal statement of the Convention,
 - c. has completed a credentialing process:
 - preferably through a local association, or

- ii. through the Credentials Committee if no associational process is completed,
- d. has submitted an Annual Church Profile within the preceding eighteen (18) months, and
- e. has contributed financially through the Convention to the Cooperative Program within the preceding eighteen (18) months.

Section 3. Credentialing

- 1. The credentialing process for affiliation through the Convention shall be as follows:
 - a. Churches shall be encouraged to go through the credentialing (or affiliation process) of their local association. That process shall be accepted by the Convention once a "Letter Recommending Affiliation" has been received from the association.
 - b. If a church chooses selects to not to affiliate directly with the Convention rather than through an association, the First and Second Vice-Presidents of the Convention and a Credentials Committee appointed by the President shall work with the leadership of the established churches and church plants not endorsed by the North American Mission Board (NAMB) pursuing affiliation with the Convention in order to receive, review, and recommend actions for the Board of Trustees, through an application process that shall include at minimum:
 - i. submitting a membership application,
 - ii. a current copy of the church constitution and bylaws,
 - iii. a current copy of the articles of faith, and
 - iv. at least one interview with church leadership (ie. pastor/elders, deacons, church council).
 - c. through a six (6) month care period, overseen by the Credentials Committee will be required for all new affiliating churches, not affiliated through a local association process.
 - d. If approved by the Credentials Committee, the church shall be presented as a potential cooperating church to the Executive Committee first, and, upon its approval, to the Board of Trustees for final approval. A vote of affirmation for affiliation is secured by 2/3 approval by the Board of Trustees.
 - e. The applying church must agree to be a cooperating church as defined in in these Bylaws, if accepted after the credentialing process.
 - A minimum six (6) month watch care period, overseen by the Credentials
 Committee, shall be required of all new affiliating churches, not affiliated through a local association.

Section 4. Dismissal

- i. The process for dismissing a church no longer in cooperation as defined in these Bylaws from affiliation with the Convention shall be as follows:
 - a. When an issue arises between annual meetings whether a church is in cooperation with the Convention, the Credentials Committee shall consider the matter and review any information available to it.
 - i. If the committee forms the opinion that a church is not in friendly cooperation with the Convention as described in Article III of the Constitution, the committee shall submit to the Board of Trustees a report stating that opinion and the committee's reasons for its opinion. The Board of Trustees shall, at its next meeting, consider the report of the Credentials Committee and determine whether the church is in cooperation with the Convention. The church in question shall be removed from the Convention membership by a 2/3 vote of the Board of Trustees. The Board of Trustee's decision shall be final unless the church appeals the decision to the Convention during the next annual meeting.
 - ii. A church which has been found not to be in cooperation may appeal the decision to the Convention by submitting a written appeal to the chair of the Credentials Committee at least 30 days prior to the Convention's annual meeting. The Credentials Committee chair shall immediately notify the Credentials Committee, the Board of Trustees, and the Executive Director-Treasurer of the Convention that an appeal to the Convention has been lodged.
 - iii. The Recording Secretary shall notify the Convention of the appeal in the initial registration report to the Convention.
 - iv. The Convention shall consider the appeal during a time established for business during the Annual Meeting. The question before the messengers will be "Shall the decision of the Credentials Committee and the Board of Trustees that [name of the church in question] is not in cooperation with the Baptist State Convention of Michigan be sustained?" One representative of the church under consideration and one representative of the Credentials Committee or Board of Trustees shall be permitted to speak to the question, subject to the normal rules of debate. When debate is concluded, the Convention shall vote whether to sustain the Board of Trustees' ruling. If the

ruling of the Board of Trustees is reversed, messengers from the church shall immediately be registered and seated in accordance with the Convention's rules.

- b. If a church is no longer deemed to be in cooperation with the Convention, as soon as possible after the annual session, the Credentials Committee shall be responsible to check all available records to determine whether the church is failing to meet all expectations of a cooperating church, as defined in these Bylaws.
- c. During the course of the following year, the Credentials Committee, the Convention President, Executive Director/Treasurer, and other appropriate staff shall make every effort to encourage non-cooperating churches to begin fulfilling all of the expectations of a cooperating church.
 - i. Affiliation shall be terminated automatically if a church is no longer meeting the criteria of a cooperating church as defined in these Bylaws after a period of 1 year eighteen (18) months.
 - ii. If a church demonstrates good cause, this provision for termination can be temporarily waived in writing for six (6) month increments, up to two extensions, at the discretion of the Executive Committee.
- 2. If a church which has been found not to be in cooperation with the Convention addresses the issues which led to that finding, it may apply to the Credentials Committee for a reconsideration of its status. If the circumstances warrant, the Credentials Committee may recommend to the Board of Trustees that the church be once again considered a cooperating church.
- 3. The committee may make inquiries of a church, but shall never attempt to exercise any authority over a church through an investigation or other process that would violate Article III of the Constitution.
- 4. An annual written report of the churches cooperating with the Convention and those churches removed from affiliation will be shared in the Convention's annual book of reports.

Section 5. Representation

- 1. Resident membership, as reported on the Annual Church Profile, shall determine messenger representation of cooperating churches in the Convention. Messengers shall be sent from cooperating churches using the following guidelines:
 - a. Each church shall have three (3) messengers for the first fifty (50) resident members.

- b. There shall be an additional messenger for each fifty (50) members or fractional part thereof, or for every one thousand dollars (\$1,000) given to the BSCM for Cooperative Program causes.
 - This does not include contributions made to the Lottie Moon Christmas
 Offering, Annie Armstrong Easter Offering, or Frances Brown State Missions
 Offering.
- 2. No church shall have more than ten (10) messengers, including the pastor.

ARTICLE III – MEETINGS

Section 1. Frequency of Annual Convention Sessions

The Convention shall meet a minimum of one (1) time annually; but the Convention may gather in additional special called meetings or emergency meetings as called by the President or Executive Director-Treasurer.

Section 2. Frequency of Board of Trustees Meetings

The Board of Trustees shall meet a minimum of three (3) times annually.

Section 3. Frequency of Executive Committee Meetings

The Executive Committee shall meet a minimum of one (1) time quarterly.

Section 3. Notification

- 1. Notice of regular meetings must be provided a minimum of fourteen (14) calendar days prior to the meeting date.
- 2. Notice of special called meetings must be provided a minimum of ten (10) calendar days prior to the meeting date. The agenda for special called meetings is restricted to the agenda distributed in the notification of the meeting.
- 3. Notice of an emergency meeting shall be given in the timeliest manner possible. An emergency meeting may be called if a situation is deemed of the utmost gravity as determined by one-half (1/2) of the members of the Executive Committee Board of Trustees. The agenda for an emergency meeting is restricted to the agenda distributed in the notification of the meeting.
- 4. Notice must be given by the appropriate leader:
 - a. Annual Session President or Executive Director-Treasurer

- b. Board of Trustees President or Executive Director-Treasure
- c. Executive Committee President or Executive Director-Treasurer
- d. Mission Committees Committee chair or appropriate Convention staff
- e. Other Committees President, Executive Officers, Appointed Committee Chairs, or Executive Director-Treasurer

Section 4. Quorum

A quorum for any properly called meeting of the Convention, Board of Trustees, Executive Committee, Mission Committees, or other organized committees shall consist of those in attendance.

Section 5. Challenge to Seating Messengers

- 1. A motion to challenge the seating of messengers from a Convention church may be submitted in writing by any duly elected messenger and shall be immediately referred to the Second Vice-Presidents serving as the Registration Officer for the Convention.
 - a. The shall work with the Credentials Committee to shall study the challenge and bring a report as soon as possible to the Convention.
 - If the Credentials Committee is not present at the annual meeting, the
 President in consultation with the First Second Vice-President shall appoint a
 temporary committee in its place or its temporary replacement.
 - ii. Upon recommendation of the Credentials Committee, the Convention in annual session reserves the right to not seat messengers from any church for failing to conform to these Bylaws, by a two-thirds (2/3) vote of the messengers present and voting.

Section 5. Parliamentary Procedure

The most current edition of *Robert's Rules of Order*, shall govern the annual session of the Convention, except where these Constitution and Bylaws prescribe otherwise. It shall be acceptable for Convention groups to use a "relaxed approach" of *Robert's Rules of Order* with group consensus.

Section 6. Parliamentarian

The President shall appoint one or more parliamentarians for meetings, when needed.

ARTICLE IV – CONVENTION EMPLOYEES / STAFF

Section 1. Employment

- 1. The Convention in session shall employ the Executive Director-Treasurer. Other Full-time Convention staff and employees shall be employed by the Executive Director-Treasurer in partnership with the Board of Trustees Executive Committee and the Executive Board, unless otherwise specified in these Bylaws.
 - a. When there is a vacancy of the Executive Director-Treasurer, the Elected Officers of the Convention Executive Committee, or a special appointed search committee, shall search for a qualified candidate and bring a recommendation to the Convention. Should the Executive Committee Board of Trustees believe someone should serve as an interim Executive Director-Treasurer, they may recommend elect that person via 2/3 vote of the Board of Trustees until a permanent Executive Director-Treasurer is employed.
 - b. Upon the vacancy of a full-time Convention staff position, the Executive Director-Treasurer shall make the recommendation of a qualified candidate to the Executive Committee and the Board of Trustees for approval.
 - c. When hiring full time Convention employees, the appropriate Convention staff in consultation with the Executive Director-Treasurer shall make the recommendation of a qualified candidate to the Executive Committee and Board of Trustees for approval.
 - d. The Executive Ministry Assistant shall be hired by the Executive Director/Treasurer.
 - e. Ministry Assistants shall be hired by the Executive Director-Treasurer and his Executive Ministry Assistant in consultation with the appropriate Convention staff.
 - f. All Convention staff and employees shall be active members of a cooperating church of the Convention.
- 2. Part-time Convention employees shall be employed/dismissed by the Convention staff with oversight of those employees with the approval of the Executive Director-Treasurer and the Executive Committee Board of Trustees.

Section 2. Employee Policies

The Board of Trustees Executive Committee shall be the Personnel Committee for the Convention and shall maintain an Employee Policy and Procedure Manual defining all

policies, relationships, job descriptions, and other information related to the employees of the Convention.

Section 3. Termination of Employees

- 1. The Board of Trustees Executive Committee may terminate the employment of any employee of the Convention that it determines to be ill suited to the position held or has engaged in conduct injurious to the Convention.
- 2. If an appeal is made by the terminated employee, the Board of Trustees Executive Committee may suspend the employee from the duties of his employment until the Board of Trustees has considered the appeal and action is taken.
- 3. Any terminated employee, regardless of the reason for termination, shall be paid their regular salary through the notice period set forth in the Employee Policy and Procedure Manual at the time of employment.

ARTICLE V - ABILITY TO ENTER AGREEMENTS

- 1. The Board of Trustees Executive Committee shall have the authority to approve and submit denominational documents, establish formal partnerships, cooperative agreements, rental agreements, building loans, etc. on behalf of the Convention.
- 2. All agreements must assist the Convention in the fulfillment of its mission, vision, values and strategy among the cooperating churches and not be in conflict with the Convention's Constitution or Bylaws.

ARTICLE VI -FINANCES

Section 1. Fiscal Year

The fiscal year of the Convention shall begin on the first (1st) day of January and close on the thirty-first (31st) day of December.

Section 2. Maintaining Financial Records

The Convention shall maintain adequate, current, and correct financial records in accordance with generally recognized accounting principles.

Section 3. Recording of Funds

All funds received and disbursed for all purposes shall be properly recorded in the records of the Convention.

Section 4. Financial Audit

An outside audit shall be conducted concerning all receipts, disbursements, investments, financial records, and reports every even numbered year, or when a new Executive Director-Treasurer is hired by the Convention. A thorough internal financial review shall be done every odd numbered year. These reports shall be available for review in the Convention offices to members in good standing of cooperative Convention churches.

Section 5. Reporting of Gifts

A report of the gifts of the churches shall be published in every edition of the official publication of the Convention, *The Baptist Beacon*, whether in print or electronic form.

ARTICLE VII – INDEMNIFICATION

Section 1. Indemnification of Directors, Officers, Employees and Agents

The Convention shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending, or completed action, suit, or proceeding, whether civil, criminal, administrative, or investigative by reason of the fact that he is or was a director, officer, employee, or agent (including volunteers) of the Convention, against expenses (including attorneys' fees), judgments, fines, and amounts paid in settlement actually and reasonably incurred by him in connection with such action, suit, or proceeding except that no indemnification shall be made in respect of any claim, issue, or matter as to which such person shall have been adjudged to be liable for gross negligence or misconduct in the performance of this duty to the Convention.

Section 2. Authorization of Indemnification

Any indemnification under this Article shall be made by the Convention only as authorized in the specific case upon a determination that indemnification of the director, officer, employee, or agent is proper in the circumstances because he has met the applicable standard of conduct set forth in this Article. Such determination shall be made by the Board of Trustees by a majority vote consisting of members who were not parties to such action, suit, or proceedings.

Section 3. Non-Exclusive Indemnification

The indemnification provided by this Article shall not be deemed exclusive of any other rights to which those seeking indemnification may be entitled under the Convention's Articles of Incorporation or Constitution, Bylaws, statutes, regulations, and agreement, any insurance purchased by the Convention, vote of the disinterested director, members or otherwise, and shall continue as to a person who has ceased to be an officer, employee, or agent of the Convention and shall be to the benefit of the heirs and personal representatives of such person.

Section 4. Insurance

The Convention shall have power to purchase and maintain insurance on behalf of any person who is or was a director, officer, employee, or agent of the Convention, against any liability asserted against him/her and incurred by him/her in any such capacity, or arising out of his/her status as such, whether or not the Convention would have the power to indemnify him/her against such liability under the provision of this Article.

ARTICLE VIII – BINDING ARBITRATION

In the event of any dispute, claim, question, or disagreement arising out of or relating to these bylaws or any other Convention matter, the parties involved shall use their best efforts to settle such disputes, claims, questions, or disagreement as befits Christians. To this effect, they shall consult and negotiate with each other in good faith and, recognizing their mutual interests not to disgrace the name of Christ, seek to reach a just and equitable solution. If

they do not reach such solution within a period of sixty (60) days, then upon notice by either party to the other, disputes, claims, questions, or differences shall be finally settled by arbitration as described in the Employee Policy and Procedure Manual.

ARTICLE IX – AMENDMENTS

Section 1. Proposing an Amendment to the Bylaws

- 1. A proposed amendment to the Bylaws by any person shall be submitted to the Board of Trustees Executive Committee not less than sixty (60) days prior to the annual session.
- 2. With the approval of the Executive Committee the amendment shall be submitted to the Board of Trustees during the meeting prior to the annual session.
- 3. With approval by the Executive Committee and the Board of Trustees, the amendment shall be presented at the annual session for debate and decision by the seated messengers of the Convention.
- 4. The Convention shall approve the amendment by a two thirds (2/3) majority of the messengers present and voting.

Section 2. Notification

If the proposed amendment is rejected by the Executive Committee or the Board of Trustees, the person proposing the amendment shall be notified in writing.

Section 3. Proposal of Rejected Amendment

A proposed amendment rejected by either the Executive Committee or the Board of Trustees may be presented by the original author of the amendment to the Convention in annual session, as long as the proposed amendment is submitted to cooperating churches no less than ninety (90) thirty (30) days before the annual meeting.

Section 4. Amendment Approval

Once submitted, the proposed amendment shall require a two thirds (2/3) majority of the seated messengers for approval. The proposed amendment shall become effective at the close of the annual session of the Convention in which it is properly considered and approved.
